Evin Daly is a specialist in child abuse and domestic violence prevention and child protection systems (State-run, NGO and volunteer-based). He has had a life-long connection to child abuse issues in Ireland and the U.S. He is the founder and CEO of One Child International Inc., (2005 to date) a child protection agency with offices in Dublin, North Miami and Sydney.

One Child International's mission is the protection of children from abuse. This is accomplished through the provision of objective, consistent, and up-to-date information on child abuse and prevention to law enforcement, medical professionals, government, and the public in the U.S. and internationally. Mr. Daly is the author of a book on understanding and preventing child abuse and domestic violence, '*Child Abuse. What You Need to Know.*' (Parker/Amazon)

### Background

Prior to retiring from business in 2003, Evin's 22-year career was spent as an operations and marketing communications specialist in the advertising industry [including Ogilvy & Mather Advertising NYC] and with emerging technology firms in London, New York and South Florida.

### Current

At One Child International Inc., Mr. Daly is an analyst of violent and criminal behavior(s) with emphasis on the victimization of women and children. He is a qualified and skilled investigator and forensic interviewer of adults. Mr. Daly has worked extensively with victims, families and perpetrators of child abuse and domestic violence. He is a court-recognized forensic interviewer of children who have been physically and sexually abused.

### Volunteer Work

**Guardian ad Litem:** Mr. Daly has been a Dependency Court Guardian ad Litem volunteer for over 11 years where he has investigated child abuse cases and represented abused, abandoned and neglected children in court. Since 2012 he has been at the 11th Judicial Circuit, Miami, previously at the 15th Judicial Circuit in Palm Beach, Florida, since 2005. He is also an independent Guardian ad Litem investigating and testifying in domestic violence cases involving children in Miami Family Court.

Other areas of volunteer work have included end-of-life counseling (Hospice-by-the-sea, Boca Raton, 2001 - 2004) and crisis counseling (ongoing since 1994).

## **2. Criminal, Offender and Victim Behaviors:**

Evin has studied criminal and offender motivation, deviant and criminal sexuality; the assessment, punishment, treatment, and management of offenders; criminal behavior analysis, the sexual victimization of children, juvenile sexual offenders, victimology, victim behaviors, suicidality, rape escalating to homicide, behavior oriented interviewing (BOI), forensic linguistics and related subjects under the tutelage of Anna Salter PhD, Kenneth V. Lanning (FBI), Prof Reid Meloy and the Academy Group, VA.

**3. Sex Offender recidivism:** Evin is qualified in sexual offender recidivism risk assessment (3rd generation) - Sexual Violence Risk (SVR-20), and the assessment and treatment of sex offenders (Salter/Lanning). He is trained in the use of the Psychopathy Checklist-Revised (PCL-R), (Meloy/Hare).

**4. Forensic Interviewer of children:** Mr. Daly was qualified in the forensic interviewing of children by *CornerHouse* in Minneapolis, Minnesota. *CornerHouse Child Sexual Abuse Forensic Interview Training - RATAAC®*. He has studied the *Extended Forensic Interview Protocol* (National Children's Advocacy Center).

**5. Forensic investigator and interviewer of adults:** Mr. Daly's qualifications in the interviewing and interrogation of adults were received from:

- **Child Exploitation and Online Protection Centre (CEOP - Master Class)** in London where he studied advanced techniques for interviewing sex offenders who target children.
- **Reid & Associates (advanced) - Reid Behavioral Analysis: Interview - Interrogation™**. (Reid trains US Federal & State Law Enforcement, Secret Service and the U.S. Military).
